# B. Possible action and recommendation on items discussed in closed session

Trustee Manske made a motion to accept the deal proposed which included: To pay half of the 50/50 totaling \$1880.00 to the Criag's for the sidewalk and have them sign a liability waiver for the walkway from their house to the right of way that is not ADA compliant. Also have Mr. Steielstad pay the Village back \$1360.00 for the corner of the sidewalk. The Village will hire Jones Concrete to fix the sidewalk and make the corner ADA compliant, second by Trustee Stern. 2 in favor 3 opposed, motion doesn't carry.

Trust Young motions to accept the offer as detailed less the reimbursement of \$1880.00 to the Craig's. To hire Jones Concrete to get the sidewalk done now, second by Trustee Brown. Motion was carried by unanimous vote.

Trustee Young made a motion to adjourn the meeting at 9:12pm, with a second by Trustee Stanton. Motion was carried by unanimous vote.
